2010 - 2011 Registration and Tuition Contract

REGISTRATION AND PRIORITY INFORMATION: The registration fee must accompany this contract. The registration fee is non-refundable and non-transferable.

1. Present students have priority for registration until May 5, 2010.
2. All other registration for enrollment will be considered in chronological order based on the date and time the application is received in the school office.
3. Registration fees are as follows:
 - Kindergarten (4 & 5) - \$350 per child
 - Grades 1 – 12 - \$600 per child
4. New Family Enrollment Fee - \$300 per family
5. Building Fee - \$500 per family

TUITION INFORMATION: Tuition is \$2,575 yearly for ½ day K4 & K5
\$3,605 yearly for K4 - 6th Grade
\$4,020 yearly for 7th - 8th Grade
\$4,635 yearly for 9th - 12th Grade

PAYMENT OPTIONS: 10 MONTH PLAN: August - May
12 MONTH PLAN: June - May

If you choose to pay for the full year, your payment must be received by August 15, 2010. For multi-child families regardless of which campus students are on, the two oldest children are charged full price. A third child receives a 25% tuition discount. A fourth child and any additional children receive a 50% discount. The New Family Enrollment Fee and the Registration Fee are not discounted. Bank Draft is available and needs to be set up in the business office.

ADMISSION POLICY: Mt. Salus Christian School does not discriminate on the basis of race, creed, color, or national and ethnic origin in its admission of students to all the rights, privileges, programs and activities generally accorded or made available to students of the school. Nor does the School discriminate on the basis of race, creed, color, or national and ethnic origin in the administration of its educational policies, admission policies, scholarship programs, and other school-administered programs.

IMPORTANT – PLEASE READ BEFORE SIGNING THIS CONTRACT:

The Board of Mt. Salus Christian School shall have the right to accept or reject any registration and tuition contract. **Once enrolled, families that leave Mt. Salus for any reason must pay tuition for two additional months beyond the date of withdrawal and educational records are held at the school until all outstanding balances have been paid.** If tuition becomes 30 days delinquent, the student may not be admitted to classes until the tuition is paid. This policy will be enforced by the school administration unless prior arrangements have been made with the Board. All accounts must be current by April in order for your child to attend class during the month of May.

PLEASE FILL OUT AND SIGN THE BACK OF THIS CONTRACT

Applicants agree to abide by all the rules and regulations established for the school and that all privileges of attendance at the school may be withdrawn from the student for academic reasons, disciplinary reasons, or failure to abide by the rules and regulations of the school.

COMMITMENT: Parents agree to the instruction of their child in the Christian Faith in all phases of the school's curriculum.

By signing this registration and tuition contract you acknowledge the acceptance of all the above conditions and stipulations governing admission, attendance, curriculum, discipline, and tuition of Mt. Salus Christian School. Your signature also creates a binding agreement to keep your tuition account current for the 2010 – 2011 academic school year.
